

Habitat for Humanity of Greater Orlando, Inc.
Release and Waiver

This Release and Waiver of Liability (the "Release"), executed on this day by the volunteer named below (the "Volunteer") and Habitat for Humanity of Greater Orlando Area, Inc., a nonprofit corporation ("Habitat"), its directors, officers, employees, and agents.

The Volunteer desires to participate in Habitat's home building program, and the activities related to the work. The Volunteer understands that the activities may include constructing residential buildings, being transported to and from work site locations, and consuming food donated for the home building program.

1. **Waiver and Release.** Volunteer does hereby release and forever discharge and hold harmless Habitat and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's participation in Habitat's home building program. Volunteer understands that Release discharges Habitat from any liability or claim that the Volunteer may have against Habitat with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's participation in Habitat's home building program. Volunteer also understands the Habitat does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance.
2. **Medical Treatment.** Volunteer does hereby release and forever discharge Habitat from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's participation in Habitat's home building program or with the decision by any representative or agent of Habitat to exercise the power to consent to medical or dental treatment as such power may be granted and authorized in the Authorization for Treatment.
3. **Assumption of the Risk.** The Volunteer understands that the home building program may include activities that may be hazardous to the Volunteer and that the food, accommodations, and medical facilities may be donated to Habitat and beyond the control of Habitat. Volunteer hereby expressly and specifically assumes the risk of injury or harm in these activities and releases Habitat from all liability for injury, illness, death, or property damage resulting from the activities of the Volunteer's participation in Habitat's home building program.
4. **Insurance.** Each Habitat Volunteer is covered by an Excess Accidental Medical Program designed to provide coverage in the event of an accidental bodily injury. Volunteers are covered while they are participated in a Habitat sponsored activity. This coverage will wrap around the volunteer's personal health insurance. If the Volunteer does not have any health insurance, then the policy becomes primary.
5. **Photographic Release.** Volunteer does hereby grant and convey unto Habitat all right, title, and interest in any and all photographic images and video or audio recordings made by Habitat during Habitat's home building program, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.
6. **Other.** Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that this release shall be governed by and interpreted in accordance with the laws of the State of Florida. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
